Hello 2018 Drivers-

Welcome to the Port Jervis Soap Box Derby! Not sure if you've heard, but you are about to be a part of the LARGEST local Soap Box Derby in the WORLD! We guarantee you will have a blast while making some new friends and fantastic memories along the way. The winner in each division will go on to represent Port Jervis at the All-American Soap Box Derby and will spend the week of July 15th – July 21st in Akron, Ohio.

Mandatory Driver Meeting: Wednesday, April 4th at 6:30 pm at the Port Jervis Middle School. Drivers picture will be taken and a lot of important information about the 2018 season will be discussed. This meeting **MUST** be attended.

Practices: May 20th & June 9th on Sussex Street

- Practice dates are Sunday, May 20th (rain date: Sun. June 3rd) and Saturday, June 9th.
- Both practices will be held on Sussex Street
- New drivers **MUST** attend a portion of both practice dates and go down the hill a minimum of 4 times at each practice for the practices to count.
- Returning drivers **MUST** attend one practice date and **MUST** go down the hill 4 times for the practice to count. If you do not practice on 6/9, you must still attend to impound your car.
- Hot dogs, snacks and soda will be available for purchase at practice and proceeds are donated to the PJSBD & the Elizabeth Ashley "Boo" Bisland Memorial Scholarship Fund.

Car Impound: June 9th on Sussex Street

- Once you are finished with practice runs on June 9th, you must impound your car.
- ALL drivers must be present with their cars 6/9 for final weigh in and inspection.
- Drivers must have their helmet and a milk crate (2 crates for masters) to store cars overnight
- T-shirts, programs/posters and other soapbox merchandise will be available for purchase.

Race Day: June 10th on Sussex Street

- Drivers report time: Super Stock-7:30am, Masters-8:45am, Stock-10:00am.
- Drivers must report back to pit area immediately following their race.

Driver Photos: **MUST** be taken at the Mandatory Meeting or at the **FIRST** practice to be included in the 2018 program/poster.

I hereby further agree to indemnify and to hold forever harmless the said Releasees from any and all claims, loss liability, damage or cost releases may incur due to my presence in the City of Port Jervis while utilizing the above-described race track facilities and /or participating in and/or observing Soap Box Derby races and/or events.

I expressly agree that this release, waiver and indemnity agreement is intended to be as broad and inclusive as permitted by the laws of the State of New York and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full force and legal effect.

I, being of lawful age, in consideration of being permitted to utilize the above-described race track facilities and/or participate in and/or observe Soap Box Derby races and/or events in the City of Port Jervis release and forever discharge Releasees, their heirs, administrators and executors of and from any and every claim, demand, action or right of action, of whatsoever kind or nature, either in law or in equity arising from or by reason of any bodily injury or personal injuries known or unknown, death, and/or property damage which may occur as a result of my utilization of the above-described race track facilities and/or any participation in and/or observation of Soap Box Derby races and/or events in the City of Port Jervis or any activity in connection therewith, whether by negligence or not.
