As such parent/guardian, I agree to my son, daughter, and/or ward of being permitted to utilize the Cincinnati Soap Box Derby road course at/in Cincinnati, and in consideration of the benefits received by myself and my child and/or ward as a result of said use, I, together with my heirs, executors, administrators, and assigns, hereby release, waive, and forever discharge and covenant not to sue the Cincinnati Soap Box Derby, its sponsors, the International Soap Box Derby, Inc., its sponsors, and/or all of their officers, agents, members, employees, full or part-time, insurers, lessees, lessors, and associates of any status whatsoever, all for the purpose herein referred to as Releasees, from all liability to me, my heirs, executors, administrators, and assigns for all loss or damage, and any claim or damage therefore, on account of injury to my person, child, and/or ward, or property or resulting in my death, whether caused by the negligence of Releasees or otherwise while I or my child/ward is utilizing the above described road course facilities and/or observing any Soap Box Derby and/or related event being held in Cincinnati.

I hereby further agree to indemnify and to hold forever harmless the said Releasees from any and all claims, loss, liability, damage, or cost Releasees may incur due to my and or my child/ward's presence while utilizing the above-described road course facilities, and/or participating in and/or observing said Cincinnati Soap Box Derby races and/or events.

I hereby assume all responsibility for and risk of bodily injury, death, or property damage due to any act or omission of Releasees while so I, or my child/ward, is utilizing the above described road course facilities and/or participating in and/or observing said Cincinnati Soap Box Derby races and/or events.

I expressly agree that this release, waiver, and indemnity agreement is intended to be as broad and inclusive as permitted by the laws of the State of Ohio and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full force and legal effect.

I, being of lawful age, as legal parent or guardian, in consideration of, and/or my child/ward, to utilize the above described racetrack facilities and/or participate in and/or observe Cincinnati Soap Box Derby races and/or events release and forever discharge Releasees, their heirs, administrators, and executors of and from any and every claim, demand, action, of whatsoever kind or nature, either in law or in equity arising from or by reason of any bodily injury or personal injuries known or unknown, death, and/or property damage which may occur as a result of my, and/or my child/ward's utilization of the above described road course facilities and/or any participation in and/or observation of Cincinnati Soap Box Derby races and/or events or any activity in connection therewith, whether by negligence or not.

If I am renting a car from the Cincinnati Soap Box derby, I hereby assume all responsibility to maintain and care for that rental car when taken from the race course facilities. I also acknowledge that I will forfeit the \$60 deposit fee if the rental car is not returned at the close of the season or if the rental car is returned damaged. Once a final inspection has been completed the \$60 deposit fee will be returned.
